ENTRY DEADLINE: APRIL 2, 2019 AT 4:30 P.M.

ELIGIBILITY

Entries are open to amateur female golfers who: a) are members in good standing of a WSGA member club; b) have an active GHIN number and USGA Handicap Index issued by a WSGA member club; and c) meet at least one of the following requirements:

- Club Champion of a WSGA Member Club (2017 or 2018)
- Champion of the Women's Champion of Champions (2014-2018)
- Champion of the Senior Women's Champion of Champions (2014-2018)
- Champion of a WSGA Championship; excluding Parent-Child and Mixed Chapman Championship (2018)
- Champion of any event on the WSGA Women's Performance Points List (2018)
- Champion of any event on the WSGA Senior Women's Performance Points List (2018)
- Top-5 on the WSGA Women's Performance Points List (as of December 31, 2018)
- Top-5 on the WSGA Women's Mid-Amateur Performance Points List (as of December 31, 2018)
- Top-5 on the WSGA Senior Women's Performance Points List (as of December 31, 2018)
- Top-5 on the WJGA Girls' Performance Points List (as of December 31, 2018)
- WJGA State Girls Champion (2018)

The field will be comprised of the first 18 women, 30 senior women, 60 men and 48 senior men to submit an entry application. Since all championships are conducted concurrently, the WSGA reserves the right to modify the field limits to achieve a full field of 156 players.

AGE

No age requirements for Amateur Championship entrants. Senior Amateur entrants must be 50 years of age or older by April 23, 2019.

ENTRIES

Entry applications can be filed online at www.thewsga.org/championships with a credit card, or by mail with a completed paper application form and check or credit card authorization form. Payment will be processed at the time of entry. A full refund will be issued to entrants who are placed on a waiting list and do not make the starting field.

Entry applications, along with the appropriate fee, must be received by the WSGA by 4:30 p.m. on April 2, 2019. Refunds due to cancellation on or before April 2, 2019 are subject to a \$10 service fee. After April 2, 2019 and up until round one pairings are released, refunds for documented and approved medical reasons are subject to a \$25 service fee. **NO REFUNDS WILL BE ISSUED AFTER ROUND ONE PAIRINGS HAVE BEEN RELEASED.**

Late entry applications may be accepted and used to fill spots if they become available up until a time that the WSGA staff establishes. Late entry applications will not be accepted unless they are accompanied by the correct entry fee, plus an additional administrative fee of \$25. Contestants must contact the WSGA in order to submit a late entry application.

CONDITIONS

The WSGA Champion of Champions Committee reserves the right to alter any of the conditions and schedules herein. The Committee reserves the right to reject the entry of any applicant, at any time, for any reason. Any decision by the Committee, in any matter, shall be final.

CODE OF CONDUCT

Unacceptable conduct or behavior on the golf course or on club property will not be tolerated and may be subject to disqualification under the WSGA Code of Conduct at any time, from any WSGA Championship. **The WSGA Code of Conduct will be provided to all contestants prior to the Championship.**

CARTS

The use of automotive carts during the championship is permitted. Cart fees are \$35 per rider, includes both rounds, and must be paid during registration. Spectator carts will not be permitted.

CADDIES

A player may provide her own caddie. Host club caddies will not be available.

DRESS CODE

The WSGA expects all contestants and their caddies to wear suitable attire on the host club property throughout the duration of the championship, including practice rounds. The full WSGA Dress Code Policy can be found online at www.thewsga.org/policies and will be provided to all players, along with any additional measures required by the host club, after the entry deadline. Gallery must adhere to the host club dress code policy. Failure to adhere to the dress code may result in disqualification and removal from the course.

PRACTICE ROUND

All contestants will be allowed one complimentary practice round prior to the championship. Consideration will be made for out-of-town players with regard to reserved starting times the day prior to the championship. Contestants can reserve practice round times directly through the golf shop. All practice round times are at the discretion of the golf shop staff.

CHAMPIONSHIP SCHEDULE

36-Hole Individual Stroke Play Competition (gross only).
In the event of a tie, the winner will be decided immediately by a hole-by-hole playoff.

TUESDAY, APRIL 23

First Round: A.M. and P.M. Starting Times

Contestants will be re-paired by 18-hole gross scores

WEDNESDAY, APRIL 24

Final Round: A.M. and P.M. Starting Times

WITHDRAWAL POLICY

All refunds prior to the entry deadline are subject to a \$10 administrative fee. Refunds are not available after the closing deadline except for documented and approved medical reasons. Refunds approved after the closing deadline, and up until round one pairings are released, are subject to a \$25 administrative fee. **NO REFUNDS WILL BE ISSUED AFTER ROUND ONE PAIRINGS HAVE BEEN RELEASED.**

During play of the championship, a competitor must notify WSGA staff and state her need to withdraw. Entrants who unofficially withdraw (by not notifying the WSGA staff or without having sufficient reason to withdraw) will not be granted entry into any future WSGA championship for a minimum of two years.

LODGING

The WSGA recommends that contestants make their lodging arrangements at the earliest possible date. The WSGA provides highly discounted rates on hotels as a part of the "WSGA Rewards" program. Contestants can access hotel bookings in close proximity to the golf course using their GHIN number online at www.thewsga.org/rewards.
